
I am transmitting the following Act, which I have signed into Public Law No. 23-14:

Congressional Act No. 23-09, entitled: "AN ACT TO AMEND PUBLIC LAW NO. 22-186, AS AMENDED BY PUBLIC LAWS NOS. 22-189 AND 23-01, BY AMENDING SECTION 5 THEREOF, TO CHANGE THE USE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF CHUUK STATE, AND FOR OTHER PURPOSES."

This Congressional Act is amending Public Law No. 23-01. Notable change of line-item Section 5(4)(g) was made to accommodate public projects and social programs for the people of Chuuk and other purposes.

AN ACT

To amend Public Law No. 22-186, as amended by Public Laws Nos. 22-189 and 23-01, by amending section 5 thereof, to change the use of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 22-186, as
2 amended by Public Laws Nos. 22-189 and 23-01, is hereby
3 further amended to read as follows:

4 "Section 5. Of the \$5,600,000 appropriated under
5 this act, \$2,400,000 shall be apportioned for public
6 projects and social programs for the people of Chuuk
7 State.


