

TWENTY-SECOND CONGRESS OF THE FEDERATED STATES OF MICRONESIA

EIGHTH SPECIAL SESSION, 2023

CONGRESSIONAL BILL NO. 22-310, C.D.1

AN ACT

To appropriate the sum of \$923,000 from the General Fund of the Federated States of Micronesia for fiscal year ending September 30, 2023, for the purpose of funding the FSMTCC – Open Access Entity (OAE), the 2023 Special Election, the 2023 Inauguration, the participation of airport managers and staff in the Airport Master Record Seminar, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$923,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for fiscal year ending September
4 30, 2023, for the purpose of funding the FSMTCC – Open Access
5 Entity (OAE), the July 2023 Special Election, the 2023
6 Inauguration, and the participation of airport managers and staff
7 in the Airport Master Record Seminar in Honolulu, Hawaii. The
8 funds appropriated under this section shall be apportioned as
9 follows:

10	(1) FSMTCC – Open Access Entity (OAE)	\$	400,000
11	(2) 2023 Special Election		300,000
12	(3) Financial assistance for state airport		
13	managers and staff to attend the Airport Master		
14	Record Seminar in Honolulu, Hawaii		23,000
15	(4) 2023 Inauguration		200,000

16 Section 2. Allotment and management of funds and lapse date.

17 All funds appropriated by this act shall be allotted, managed,

1 administered and accounted for in accordance with applicable laws,
2 including, but not limited to, the Financial Management Act of
3 1979. The allottee shall be responsible for ensuring that these
4 funds, or so much thereof as may be necessary, are used solely for
5 the purpose specified in this act, and that no obligations are
6 incurred in excess of the sum appropriated. The allottee of the
7 funds appropriated under Section 1(1) and (3) of this act shall be
8 the Secretary of the Department of Transportation, Communications
9 and Infrastructure or his designee. The allottee of the funds
10 appropriated under Section 1(2) and (4) of this act shall be the
11 President of the Federated States of Micronesia. The authority of
12 the allottee to obligate funds appropriated by this act shall
13 lapse on September 30, 2023.

14 Section 3. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.


