CONGRESSIONAL BILL NO. 23-01

AN ACT

To further amend Public Law No. 22-86, as amended by Public Laws Nos. 22-101, 22-102, 22-106, 22-140, 22-147, 22-161, 22-168, 22-185 and 22-197 by amending section 2 thereof, to change the use of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 22-86, as amended by
2 Public Laws Nos. 22-161 and 22-168, is hereby further amended to

5 act, \$1,600,000 shall be apportioned for priority
