AN ACT

To appropriate \$56,669,874 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2024, to provide funding for the operations of all branches of the National Government of the Federated States of Micronesia, its agencies, various programs, grants, subsidies and contributions and capital and human resources development, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Purpose. The purpose of this act is as  
2 follows: To appropriate the sum of \$56,669,874 from the General  
3 Fund of the Federated States of Micronesia for the fiscal year  
4 ending September 30, 2024, for the purpose of funding the  
5 operations of all branches of the National Government of the  
6 Federated States of Micronesia, its agencies, various programs,  
7 grants, subsidies and contributions, and Capital and Human  
8 Resources Development. The sum appropriated herein shall be  
9 apportioned as follows:

10       Section 2. Operating expenses of the Executive Branch.  
11 The sum of \$33,400,114 or so much thereof as may be necessary,  
12 is hereby appropriated from the General Fund of the Federated  
13 States of Micronesia for the fiscal year ending September 30,  
14 2024, for the purpose of funding the operations of the  
15 Executive Branch of the National Government during the fiscal  
16 year 2024. Of the total amount of funds appropriated herein,  
17 \$366,570 shall be deemed to come from funds available under

1 Supplemental Education Grant or successor program. The sum  
2 appropriated by this section shall be apportioned as follows:

18 The President, Speaker, Chief Justice and Public Auditor may  
19 reprogram up to 10 percent to or from the funds appropriated  
20 in sections 2 (Operating expenses of the Executive Branch), 3  
21 (Operating expenses of the Legislative Branch), 4 (Operating  
22 expenses of the National Judicial Branch), and 5 (operating  
23 expenses of the National Public Auditor). Reprogramming of  
24 funds within a department, office or agency shall be effected  
25 by the head of such department, office or agency by specifying

1 in writing to the Secretary of the Department of Finance and  
2 Administration of the FSM National Government, the accounts  
3 for which funding is either increased or decreased.  
4 Reprogramming other than as specified herein is not permitted,  
5 and more specifically, reprogramming into or out of any line  
6 item contained in section 8 (Grants, Subsidies and  
7 Contributions) or section 9 (Capital and Human Resources) is  
8 not permitted. The President shall report to Congress within  
9 one month of the last day of each financial quarter all  
10 amounts reprogrammed inter or intra a department, office or  
11 agency.

12 Section 12. Allotment and management of funds and lapse  
13 dates.

14 (1) General provisions.

15 (a) All funds appropriated by this act shall be  
16 allotted, managed, administered and accounted for in  
17 accordance with applicable law, including, but not  
18 limited to, the Financial Management Act of 1979.

19 (b) The allottees shall be responsible for ensuring  
20 that these funds, or so much thereof as may be necessary,  
21 are used solely for the purposes specified in this act,  
22 and that no obligations are incurred in excess of the  
23 sums appropriated.

24 (2) Allottees. The allottees of the funds appropriated by  
25 this act are as follows:

1           (a) Section 2 - the allottee of these funds shall be  
2           the President of the Federated States of Micronesia;

3           (b) Section 3 - the allottee of these funds shall be  
4           the Speaker of the Congress of the Federated States of  
5           Micronesia;

6           (c) Section 4 - the allottee of these funds shall be  
7           the Chief Justice of the Supreme Court of the Federated  
8           States of Micronesia;

9           (d) Section 5 - the allottee of these funds shall be  
10          the Public Auditor of the Federated States of Micronesia;

11          (e) Sections 6 through 9 - the allottee of these  
12          funds shall be the President of the Federated States of  
13          Micronesia; PROVIDED, HOWEVER, that for the following  
14          subsections of sections 8 through 9 of this act:

15               (i) Section 9 (1)(a) through (c) - the allottee  
16               of these funds shall be the President of the College  
17               of Micronesia-FSM.

18          (3) Lapse date. The authority of the allottees to  
19          obligate funds appropriated by this act shall lapse as of  
20          September 30, 2024; PROVIDED, HOWEVER, that the funds  
21          appropriated under section 9 of this act shall not lapse.
