To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2023, for the purpose of funding relief efforts for the victims of a recent fire in Maui, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Appropriation. The sum of \$500,000 is hereby
- 2 appropriated from the General Fund of the Federated States of
- 3 Micronesia for the fiscal year ending September 30, 2023.
- 4 Section 2. Purpose. The purpose of the appropriation in
- 5 section 1 is to provide funding to humanitarian and relief
- 6 efforts for the victims of a recent fire in Maui. The funds
- 7 appropriated shall be apportioned as follows:
- 9 Section 3. Allotment and management of funds and lapse
- 10 date. All funds appropriated by this act shall be allotted,
- 11 managed, administered and accounted for in accordance with
- 12 applicable laws, including, but not limited to, the Financial
- 13 Management Act of 1979. The allottee shall be responsible for
- 14 ensuring that these funds, or so much thereof as may be
- 15 necessary, are used solely for the purpose specified in this
- 16 act, and that no obligations are incurred in excess of the sum
- 17 appropriated. The allottee of the funds appropriated under
- 18 this act shall be the President. The authority of the allottee

1	under this act may be sub-allotted to a cabinet secretary or
2	secretaries in accordance with the Financial Management Act and
3	shall lapse on December 31, 2023.
4	Section 4. This act shall become law upon approval by the
5	President of the Federated States of Micronesia or upon its
6	becoming law without such approval.
