CONGRESSIONAL BILL NO. 23-13, C.D.1

---

AN ACT

To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2023, for the purpose of funding relief efforts in Guam and the Commonwealth of the Northern Marianas Islands in response to the damage caused by Super Typhoon Mawar, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. The sum of \$500,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 2023, for the purpose of funding relief efforts in  
5 Guam and the Commonwealth of the Northern Marianas Islands in  
6 response to the damage caused by Super Typhoon Mawar. The funds  
7 appropriated under this section shall be apportioned as follows:

8           (1) Guam Super Typhoon Mawar Relief.....\$ 400,000

9           (2) Commonwealth of the Northern Marianas  
10 Islands Super Typhoon Mawar Relief..... 100,000


11       Section 2. Allotment and management of funds and lapse  
12 date. All funds appropriated by this act shall be allotted,  
13 managed, administered and accounted for in accordance with  
14 applicable laws, including, but not limited to, the Financial  
15 Management Act of 1979. The allottee shall be responsible for  
16 ensuring that these funds, or so much thereof as may be  
17 necessary, are used solely for the purpose specified in this  
18 act, and that no obligations are incurred in excess of the sum

1 appropriated. The allottee of the funds appropriated under  
2 section 1 of this act shall be the President of the Federated  
3 States of Micronesia or his designee. The authority of the  
4 allottee to obligate funds appropriated by this act shall lapse  
5 on September 30, 2023.

6 Section 3. This act shall become law upon approval by the  
7 President of the Federated States of Micronesia or upon its  
8 becoming law without such approval.
