PUBLIC LAW NO. 23-22

AN ACT

To amend Public Law No. 21-157, as amended by Public Laws Nos. 21-179, 21-216, 22-17, 22-35, 22-44 and 22-118, by amending section 4 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
