AN ACT

To further amend Public Law No. 20-178, as amended by Public Laws Nos. 21-01, 21-07, 21-36, 21-53, 21-56, 21-102, 21-115, 21-137, 21-165, 21-178, 21-200, 21-218, 21-226, 21-249, 22-27, 22-63, 22-73, 22-82, 22-138, 22-145 and 23-42, by amending section 3 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.
