## A BILL FOR AN ACT

To authorize the appropriation of \$136,000 and to appropriate \$46,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1983, for the purpose of funding a Ponape State livestock center, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$136,000, or so much thereof as may be
- 2 necessary, is hereby authorized for appropriation, and the sum of \$46,000,
- 3 or so much thereof as may be necessary, is hereby appropriated from the
- 4 General Fund of the Federated States of Micronesia for the fiscal year
- 5 ending September 30, 1983, for the purpose of funding a Ponape State
- 6 livestock center.

- 7 Section 2. The intention of this authorization and appropriation is
- 8 to assist and encourage economic development and production projects in
- 9 Ponape State. In order to recognize Ponape State's responsibilities for
- 10 its own economic development and to avoid hindering Ponape State's creative
- 11 initiative in managing development projects, all funds appropriated by this
- 12 act will be made available on a 50/50 matching basis only. The allottee
- 13 will receive no funds until he has presented to the Secretary of Finance
- 14 adequate proof that the State of Ponape has appropriated a sum equal to the
- 15 amount of money appropriated under this act for the Ponape State livestock
- 16 center.
- 17 Section 3. The Department of Resources and Development for the
- 18 Federated States of Micronesia will submit to the Congress a written report
- 19 every six months reviewing the activities of the Ponape State livestock
- 20 center and recommending any improvements that might be made in the operation
- 21 of the center. Future funding of the livestock center by the Congress will
- 22 be based on the findings and recommendations of the representative of the
- 23 Department of Resources and Development.
- Section 4. The Governor of Ponape State or his designee shall be the
- 25 allottee of funds under this act and he shall be responsible for all aspects

1 of administration and reporting of funds expenditures and progress of the center to Federated States of Micronesia Department of Resources and 2

Development.

Section 5. All funds appropriated by this act shall be managed, 4

administered, and accounted for in accordance with applicable law, including, 5

but not limited to, the Financial Management Act of 1979. Funds appropriated

under this act shall lapse as of September 30, 1985.

8 Section 6. This act shall become law upon approval by the President

of the Federated States of Micronesia or upon its becoming law without

10 such approval.
