A BILL FOR AN ACT

To appropriate the sum of \$4,332,275 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the operations of the executive branch, National judiciary, public auditor, and other programs of the National Government of the Federated States of Micronesia during fiscal year 1982, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,320,100, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the Federated  
3 States of Micronesia for the fiscal year ending September 30, 1982, for  
4 the operations of the executive branch of the National Government of the  
5 Federated States of Micronesia during fiscal year 1982. The sum  
6 appropriated by this section shall be apportioned as follows:

1 Section 2. The sum of \$375,600, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the Federated  
3 States of Micronesia for the fiscal year ending September 30, 1982, for  
4 the operations of the National Judiciary during fiscal year 1982.

5 Section 3. The sum of \$35,000, or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund of the Federated  
7 States of Micronesia for the fiscal year ending September 30, 1982, for  
8 the operations of the public auditor during fiscal year 1982.

9 Section 4. The sum of \$520,000, or so much thereof as may be  
10 necessary, is hereby appropriated from the General Fund of the Federated  
11 States of Micronesia for the fiscal year ending September 30, 1982, for  
12 the operations of the Commission on Future Political Status and  
13 Transition during fiscal year 1982. The sum appropriated by this section  
14 shall be apportioned as follows:

- 15 (1) Salaries and personnel benefits. . . . . \$ 116,500
- 16 (2) Official travel. . . . . 155,000
- 17 (3) Contractual services . . . . . 203,000
- 18 (4) Miscellaneous expenses . . . . . 45,500

19 Section 5. The sum of \$257,200, or so much thereof as may be  
20 necessary, is hereby appropriated from the General Fund of the Federated  
21 States of Micronesia for the fiscal year ending September 30, 1982,  
22 for the Board of Regents of the College of Micronesia during fiscal  
23 year 1982.

24 Section 6. The sum of \$381,200, or so much thereof as may be  
25 necessary, is hereby appropriated from the General Fund of the Federated

4 Section 7. The sum of \$1,443,175, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund of the Federated  
6 States of Micronesia for the fiscal year ending September 30, 1982, for  
7 grants and contributions from the National Government of the Federated  
8 States of Micronesia during fiscal year 1982. The sum appropriated by  
9 this section shall be apportioned as follows:

18 Section 8. The sums appropriated by this act shall be administered  
19 in accordance with the provisions of applicable law, including, but not  
20 limited to the Financial Management Act of 1979. The President, or his  
21 designated allottee, may reallocate up to 10 percent of the line items in  
22 section 1 and section 4 of this act. The authority to obligate the  
23 funds appropriated by this act shall lapse as of September 30, 1982.

24 Section 9. This act shall become law upon approval by the President  
25 of the Federated States of Micronesia or upon its becoming law without


