A BILL FOR AN ACT

To create a Federated States of Micronesia National Government motor pool, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Establishment of National Government motor pool. There is  
2 hereby established as an agency of the National Government of the Federated  
3 States of Micronesia a National Government motor pool.

4       Section 2. Purposes of National Government motor pool. The purposes  
5 of the National Government motor pool are:

6           (1) To ensure economical utilization of National Government-owned  
7 vehicles,

8           (2) To eliminate the unauthorized use of National Government-owned  
9 vehicles;

10          (3) To provide a ready means of transportation for National Govern-  
11 ment employees and officers on National Government business; and

12          (4) To provide a central administrative location for the mainte-  
13 nance, care, and operation of selected National Government-owned vehicles.

14       Section 3. Operation of National Government motor pool. The National  
15 Government motor pool shall be operated by the Division of Property and  
16 Supply within the Department of Finance.

17       Section 4. Executive officer defined. As used in this act, "executive  
18 officer" means an employee of the Division of Property and Supply within the  
19 Department of Finance who has been designated by the Secretary of that Depart-  
20 ment to operate the National Government motor pool.

21       Section 5. Duties of executive officer. The executive officer shall be  
22 responsible for proper maintenance and storage of all vehicles assigned to the  
23 motor pool and shall maintain records to show the location of and the operating  
24 and maintenance costs of vehicles assigned to the motor pool.

25       Section 6. Employees, facilities of National Government motor pool. The

1 executive officer is authorized to use the existing employees and facilities  
2 of his division and to employ such additional employees or procure such  
3 additional facilities as may be necessary to carry out the provisions of  
4 this act.

5 Section 7. Location, branches. The National Government motor pool shall  
6 be located in Kolonia, Ponape, and may have branches at such other locations  
7 as may be designated by the President.

8 Section 8. Assignment of vehicles to motor pool. The President may  
9 assign any National Government-owned vehicle to the National Government motor  
10 pool.

11 Section 9. Motor pool funds.

12 (1) The sum of \$30,000 is hereby appropriated from the General  
13 Fund of the Federated States of Micronesia for the purpose of establishing  
14 and maintaining a National Government motor pool. No money from these funds  
15 may revert to the General Fund of the Federated States of Micronesia at any  
16 time. The funds herein appropriated shall be administered and managed in  
17 accordance with the provisions of the Financial Management Act of 1979.

18 (2) All operating, maintenance, and repair costs for vehicles  
19 assigned to the National Government motor pool must be paid for from the  
20 motor pool fund.

21 (3) All fees, including costs and other money received by the  
22 National Government motor pool and all proceeds from the sale of vehicles,  
23 must be deposited with the National Treasury of the Federated States of  
24 Micronesia for credit to the fund.

25 Section 10. Regulations. The executive officer, subject to the

1 approval of the President, shall promulgate regulations necessary for the  
2 administration of this act. Such regulations shall have the force and  
3 effect of law.

4 Section 11. Effective date. This act shall become law upon approval  
5 by the President of the Federated States of Micronesia or upon its becoming  
6 law without such approval.
