A BILL FOR AN ACT

To amend section 403 of title 40 of the Code of the Federated States of Micronesia, reducing the size of the Board of Regents of the College of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 403 of title 40 of the Code of the Federated
- States of Micronesia is hereby amended to read as follows: 2

"Section 403. Board of Regents. There shall be a Board of Regents of the College of Micronesia which shall consist of the following members who shall serve for the following terms:

(1) one heabet from each administrative district of the Tthat Tettitoty abbointed by the district administrators with the advice and consent of the district registatutel to setve a tetu of fout yeatel btoyided that the district Administrator shall submit his momination to the district legislatute for the fitst heabet appointed putsuant to this subsection on of befote notenbet 10/ 1977/ stotided tutthet/ that at the fitst boatd heeking the heabets appointed putspant to this subsection shall by Ataming lots designate three members to setve an initial term of two yeatsh

(1) one member each from the Republic of Belau, the -Federated States of Micronesia, and the Marshall Islands, appointed by the Chief Executive of that political entity, with the advice and consent of the local legislative body, to serve a term of 3 years; provided that at the first Board meeting the members appointed pursuant to this subsection shall, by drawing lots, determine a member to serve an initial term of 1 year, a member to serve an initial term of 2 years, and a member to serve an initial term of 3 years;
