A BILL FOR AN ACT

To amend section 5 of Public Law No. 3-18 to appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1984, for the purpose of aiding the Micronesian Maritime Authority in the surveillance of the extended fishery zone, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
