## AN ACT

To further amend Public Law No. 3-18, as amended by Public Laws Nos. 3-39, 3-41, and 3-42, by further amending section 5 regarding operating expenses of agencies of the National Government to reallocate funds under subsection (7), and for other purposes.

100	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 5 of Public Law No. 3-18, as amended by
2	Public Laws Nos. 3-39, 3-41, and 3-42, is hereby further amended
3	to read as follows:
4	"Section 5. Operating expenses of agencies of the
5	National Government. The sum of \$1,306,384, or so much
6	thereof as may be necessary, is hereby appropriated from
7	the General Fund of the Federated States of Micronesia,
8	and the sum of \$1,200,000, or so much thereof as may be
9	necessary, is hereby appropriated from the United States
10	Grant Special Fund for the fiscal year ending September 30,
11	1984, for the operations of independent agencies,
12	commissions, authorities, boards, bureaus, and other
13	organizations of the National Government of the Federated
14	States of Micronesia during fiscal year 1984. The sums
15	appropriated by this section shall be apportioned as follows:
