## A RESOLUTION

Creating a Special Investigating Committee pursuant to chapter 4 of title 3 of the Code of the Federated States of Micronesia to investigate the administration and management of funds appropriated or otherwise provided for the Community College of Micronesia in fiscal years 1982, 1983, and 1984 by the Federated States of Micronesia and to report its findings and recommendations to the Congress of the Federated States of Micronesia for appropriate action within 30 days of the adoption of this resolution.

- 1 WHEREAS, the Federated States of Micronesia has appropriated or
- 2 otherwise provided funds in fiscal years 1982 through 1984 for the College of
- 3 Micronesia; and
- WHEREAS, such funds included funds for the construction of a new
- 5 dormitory at the Community College of Micronesia in the State of Ponape; and
- 6 WHEREAS, on information and belief, funds appropriated or otherwise
- 7 provided for the construction of the new dormitory by the Federated States
- 8 of Micronesia and from other sources would have been sufficient to complete
- 9 the construction of the new dormitory; and
- WHEREAS, on information and belief, funds provided for other purposes
- 11 were used for the construction of the new dormitory; and
- 12 WHEREAS, the construction of the new dormitory has not been completed
- 13 to date; and
- 14 WHEREAS, the Community College of Micronesia is presently asking
- 15 Congress to appropriate funds to complete the construction of the new
- 16 dormitory; now, therefore,
- 17 BE IT RESOLVED by the Third Congress of the Federated States of
- 18 Micronesia, Fourth Regular Session, 1984, that a Special Investigating
- 19 Committee is hereby created pursuant to chapter 4 of title 3 of the Code
- 20 of the Federated States of Micronesia to investigate the administration and
- 21 management of funds appropriated or otherwise provided by the Federated
- 22 States of Micronesia to the Community College of Micronesia; and
- BE IT FURTHER RESOLVED that the Speaker of the Congress of the
- 24 Federated States of Micronesia is hereby directed to appoint three Senators
- 25 to be members of the Special Investigating Committee and to designate one

1	of the Senators as chairman; and
2	BE IT FURTHER RESOLVED that the Special Investigating Committee
3	shall complete its task within 30 days, at the end of which time it shall
4	report its findings and recommendations for appropriate action to the
5	Congress of the Federated States of Micronesia; and
6	BE IT FURTHER RESOLVED that certified copies of this resolution be
7	transmitted to the Speaker of the Congress of the Federated States of
8	Micronesia, the President of the Federated States of Micronesia, and the
9	Rector of the Board of Regents of the College of Micronesia.
