A BILL FOR AN ACT

To amend Public Law No. 3-48 by amending sections 1, 5, and 6 to appropriate the sum of \$304,200 from the General Fund of the Federated States of Micronesia and the sum of \$204,128 from the United States Grant Special Fund for the fiscal year ending September 30, 1985, for the purpose of providing supplemental funding for the Department of Finance, the Office of the Attorney General, the Office of the Public Defender, the Office of the Budget, the Office of Planning and Statistics, the Office of Public Information, the Micronesian Maritime Authority, the Truk State Judiciary, and the general election, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-48 is hereby amended
2 to read as follows:

3 "Section 1. Operating expenses of the executive branch.

4 The sum of ~~\$5,861,043~~ 5,861,043, or so much thereof as may
5 be necessary, is hereby appropriated from the United States
6 Grant Special Fund for the fiscal year ending September 30,
7 1985, for the operations of the executive branch of the
8 National Government of the Federated States of Micronesia
9 during fiscal year 1985. The sums appropriated by this

10 the sum of \$312,109, or so much thereof as may be
11 necessary, is hereby appropriated from the United States
12 Grant Special Fund for the fiscal year ending September 30,
13 1985, for the operations of independent agencies,
14 commissions, authorities, boards, bureaus, and other
15 organizations of the National Government of the Federated
16 States of Micronesia during fiscal year 1985. The sums
17 appropriated by this section shall be apportioned as



 18 the Federated States of Micronesia during fiscal year
 19 1985. The sums appropriated by this section shall be
