A BILL FOR AN ACT

To amend section 5 of Public Law No. 3-18 to appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1984, for the purpose of aiding the Micronesian Maritime Authority in the surveillance of the extended fishery zone, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 3-18 is hereby amended to  
2 read as follows:

3 "Section 5. Operating expenses of agencies of the National  
4 Government. The sum of ~~\$1,188,884~~ 1,288,884, or so much  
5 thereof as may be necessary, is hereby appropriated from the  
6 General Fund of the Federated States of Micronesia, and the  
7 sum of \$1,200,000, or so much thereof as may be necessary,  
8 is hereby appropriated from the United States Grant Special  
9 Fund for the fiscal year ending September 30, 1984, for the  
10 operations of independent agencies, commissions, authorities,  
11 boards, bureaus, and other organizations of the National  
12 Government of the Federated States of Micronesia during fiscal  
13 year 1984. The sums appropriated by this section shall be  
14 apportioned as follows:


