



I have the honor to transmit herewith Congressional Act No. 3-44, "AN ACT TO AMEND SECTION 2 OF PUBLIC LAW NO. 3-18, AS AMENDED BY PUBLIC LAW NO. 3-39, TO APPROPRIATE A SUPPLEMENTAL SUM OF \$5,000 FOR THE LEGISLATIVE BRANCH OF THE NATIONAL GOVERNMENT, TO REALLOCATE FUNDS ALREADY APPROPRIATED, AND FOR OTHER PURPOSES.", which was passed on February 15 by the Third Congress of the Federated States of Micronesia, Second Special Session, 1984, by a two-thirds vote of all State delegations as required and as duly certified.

AN ACT

To amend section 2 of Public Law No. 3-18, as amended by Public Law No. 3-39, to appropriate a supplemental sum of \$5,000 for the legislative branch of the National Government, to reallocate funds already appropriated, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 3-18, as amended by
2 Public Law No. 3-39, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of \$1,503,635, or so much thereof as may be necessary,
5 is hereby appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending
7 September 30, 1984, for the operations of the legislative
8 branch of the National Government of the Federated States of
9 Micronesia during fiscal year 1984. The sums appropriated
10 by this section shall be apportioned as follows:

A BILL FOR AN ACT

To amend section 2 of Public Law No. 3-18, as amended by Public Law No. 3-39, to appropriate a supplemental sum of \$8,000 for the legislative branch of the National Government, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 3-18, as amended by
2 Public Law No. 3-39, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of ~~\$1,498,635~~ 1,506,635, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1984, for the operations of the legis-
8 lative branch of the National Government of the Federated
9 States of Micronesia during fiscal year 1984. The sums
10 appropriated by this section shall be apportioned as follows:
