
A BILL FOR AN ACT

To amend section 6 of Public Law No. 3-13 to provide for the compensation of the Postmaster General of the Federated States of Micronesia and State postmasters, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 3-13 is hereby amended to read
2 as follows:

3 "Section 6. Applicability of the National Public Service System
4 Act; compensation for the Postmaster General and State
5 postmasters.

6 (1) The Postmaster General and the State postmasters shall
7 be exempt from the National Public Service System Act, but all
8 other employees of the National Postal System shall be covered
9 by said act, except as may otherwise be provided by law.

10 (2) Except as provided in this section, the Postmaster
11 General of the Federated States of Micronesia and the State
12 postmasters shall not be entitled to any benefits, remuneration,
13 salary, or any other form of compensation:

14 (a) The Postmaster General shall receive an annual
15 salary equal to the salary determined by the President for
16 Secretaries of executive departments. The salaries of State
17 postmasters shall be determined by the Postmaster General;
18 PROVIDED, however, that the salary of a State postmaster shall not
19 exceed the salary of the Postmaster General.

20 (b) The Postmaster General and State postmasters
21 shall not be entitled to any form of additional compensation for
22 any work performed in excess of 40 hours per week.

23 (c) The Postmaster General and State postmasters shall
24 be entitled to participate in the National Government worker's
25 compensation insurance, group health insurance, and group life

1 insurance programs, under the same terms and conditions which
2 apply to employees of the National Public Service System.

3 (d) Any Postmaster General or State postmaster who is
4 recruited from a location other than the State in which his duty
5 station will be located is entitled to recruitment, housing, and
6 repatriation benefits equivalent to those provided to employees
7 of the National Public Service System.

8 (e) Paragraph (a) this subsection and, except as
9 otherwise determined by the Postmaster General, paragraphs (b),
10 (c), and (d) of this subsection shall not apply to State
11 postmasters during the period for which the United States Postal
12 Service has agreed to pay for the salaries and benefits of
13 employee positions under paragraph 3 of the 'Agreement
14 Concerning Postal Services Between the United States Postal
15 Service and the Government of the Federated States of
16 Micronesia'."

17 Section 2. This act shall become law upon approval by the President
18 of the Federated States of Micronesia or upon its becoming law without
19 such approval.
