THIRD CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST SPECIAL SESSION, 1983

CONGRESSIONAL BILL NO. 3-120

AN ACT

To amend section 205 of title 52 of the Code of the Federated States of Micronesia to reduce the maximum base salary of public service employees from a biweekly rate of \$1,256 to a biweekly rate of \$787.20, to freeze current base salaries in excess of the maximum rate, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 205 of title 52 of the Code of the Federated States of Micronesia is hereby amended to read as follows:

"Section 205. Base salary schedule of biweekly salary rate.

2 Section 2. The provisions of section 1 of this act shall not
3 operate to decrease the base salary biweekly rate of employees employed
4 on the effective date of this act. Furthermore, the base salary
5 biweekly rate of such employees shall not be increased beyond the rate
6 in effect on the effective date of this act.

7 Section 3. This act shall become law upon approval by the President
8 of the Federated States of Micronesia or upon its becoming law without
9 such approval.
