## A BILL FOR AN ACT

To authorize any trial justice of the National Courts to review a sentence he imposed on a prisoner, after said prisoner has served one-third of his

sentence, and, in the case of any prisoner serving a life sentence, after he has served 5 years of his sentence, for the purpose of determining the eligibility for parole of said prisoner, and for other purposes.
BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
Section 1. <u>Authorization</u> . Any trial justice of the National Courts,
2 or any duly appointed temporary justice thereof, is hereby authorized to
3 review a sentence he imposed on a prisoner, after the prisoner has
4 served one-third of his sentence, and, in the case of any prisoner
5 serving a life sentence, after said prisoner has served 5 years of his
6 sentence, for the purpose of determining the eligibility for parole of
7 said prisoner.
8 Section 2. Retroactivity. The application of this act shall be
9 retroactive to July 12, 1981.
Section 3. <u>Effective date</u> . This act shall become law upon
ll approval by the President of the Federated States of Micronesia or upon
12 its becoming law without such approval.
