1	Section 1. Section 115 of title 51 of the Code of the Federated

4	ment contractors.						
. 5	(1) The Trust Territory Government shall not enter into						
6	any contract whose primary purpose is the construction of any						
7	building, airport, road, harbor, or any other thing, unless						
8	such contract provides that if the contractor utilizes non-						
9	resident labor as defined in this chapter and if such con-						
10	tractor provides either transportation, lodging or lodging						
11	expenses, or room or board expenses to any such employee,						
12	then such contractor shall provide the same benefits to						
13	resident employees, as defined in this title.						
14	(2) Transportation, lodging or lodging expenses, or						
15	room or board expenses need not be provided when a resident						
16	employee maintains his principal place of residence within						
17	normal commuting distance, as defined by regulations imple-						
18	. menting Public Law No. 4C-49, from his place of employment						
19	with such contractor.						
20	(3) No person hired by the Federated States of Micro-						
21	nesia or by a contractor for the Federated States of Micro-						
22	nesia to work on the construction of any building, airport,
