A BILL FOR AN ACT

To establish a National Scholarship Board for the purpose of administering educational scholarship funds made available pursuant to section 216(a)(3) of the Compact of Free Association between the Federated States of Micronesia and the United States of America; to authorize the award of such scholarships; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Purpose. The purpose of this act is to establish a
- 2 National Scholarship Board for the administration and oversight of post-
- 3 secondary educational scholarship programs for citizens of the Federated
- 4 States of Micronesia.
- 5 Section 2. Definitions. As used herein, unless otherwise indicated
- 6 by the context:
- 7 (1) "Board" means the National Scholarship Board;
- 8 (2) "Chief of the Division of Education" means the Chief of the
- 9 Division of Education within the Department of Social Services of the
- 10 Federated States of Micronesia, or his designee;
- 11 (3) "Compact of Free Association" means the Compact of Free Associa-
- 12 tion between the Federated States of Micronesia and the United States of America;
- 13 (4) "Grant" means an award of financial assistance without an
- 14 obligation to repay, except through such services in the National interest as may be
- 15 required pursuant to this act;
- 16 (5) "Loan" means an award of financial assistance with
- an obligation to repay, either through repayment of the principal
- 18 amount with interest at a rate below the market rate of interest,
- 19 or through services in the National interest, or a combination
- 20 thereof;
- 21 (6) "Post-secondary education" means a course of study
- 22 at an institution of higher education which:
- (a) Admits as regular students only persons having
- 24 a diploma from a school providing secondary education;
- 25 (b) Is legally authorized to provide a program of

1	education beyond secondary education; and
2	(c) Provides an educational program for which it
3	awards a bachelor's degree; a graduate or professional degree
4	requiring study beyond the bachelor's degree level; or which
5	provides not less than a 2-year program which is acceptable for
6.	full credit toward a bachelor's degree;
7	(7) "President" means the President of the Federated
8	States of Micronesia; and
9	(8) "Scholarship" means both grants and loans.
10	Section 3. National Scholarship Board-Establishment and
11	membership. There is hereby established the National Scholarship
12	Board which shall consist of seven members, serving at the pleasure
13	of the President. The membership of the Board shall be composed as
14	follows:
15	(1) Four members shall be representatives of each of the
16	four States, to be chosen by the President in consultation with the
17	Governors of the respective States;
18	(2) Three of the members of the Board shall be the
19	Chairman of the Board of Education of the Federated States of .
20	Micronesia; the Personnel Officer of the Federated States of
21	Micronesia, or his designee; and the Chief of the Division of
22	Education within the Department of Social Services of the Federated
23	States of Micronesia, or his designee;
24	(3) The Chief of the Division of Education shall be
25	executive officer of the Board and shall have no vote except in the

event of a tie, in which case he shall cast the deciding vote; and

(4) The rector of the Board of Regents of the College of Micronesia, or his designee, shall be invited to participate as a non-voting member in all the activities and meetings of the Board.

Section 4. National Scholarship Board-Tenure of members.

- (1) The members of the Board who are representatives of the four States shall serve for 3 years; PROVIDED, however, that when the Board is first appointed, two members shall serve for a term of 2 years, and two members for a term of 3 years from the date of the organizational meeting of the Board. The terms of the respective members shall be determined by drawing lots at the organizational meeting of the Board.
- (2) Any vacancy created by a representative of one of the States shall be filled for the remainder of that representative's term by appointment by the President after consultation with the Governor of the State of the member creating the vacancy.

Section 5. <u>Mational Scholarship Board-Organization and</u> meetings.

(1) The Board shall elect from among its members, by majority vote, a chairperson who shall serve for such term as may be prescribed by the Board, except that the Chief of the Division of Education shall not be elected as chairperson. In the event of the absence or disability of the chairperson, the Board may designate another member to preside during the meeting. Four

1 members of the Board shall constitute a quorum.

- 2 (2) The Board shall meet at such times and places within the
- Federated States of Micronesia as it may designate, but not less than once
- 4 each year. The members shall be notified of meetings by the Chief of the Division
- 5 of Education, in writing, at least 2 weeks before the date of any meeting.

- 11 Section 6. Duties and functions of the National Scholarship Board.
- 12 The Board's duties and functions shall be as follows:
- (1) The Board shall have the sole power to award scholarships out
- 14 of funds made available for such purpose by the United States of America
- 15 under section 216(a)(3) of the Compact of Free Association;
- 16 (2) The Board shall establish annually the proportion of
- 17 scholarships to be awarded as grants and as loans; PROVIDED, however,
- 18 that all individual recipients of scholarships must be citizens of the
- 19 Federated States of Micronesia; PROVIDED FURTHER that any institution
- 20 receiving scholarship funds must be AM a United States accredited post-
- 21 secondary educational institution in the Federated States of Micronesia,
- 22 ϕt 1/1 the United States of America/ or its territories and possessions.
- 23 the Republic of the Marshall Islands or the Republic of Palau;
- 24 (3) The Board shall establish eligibility requirements and
- 25 curricular criteria on which the award of scholarships shall be based, which
