## A BILL FOR AN ACT

To further amend Public Law No. 4-51, as amended by Public Law No. 4-88, by adding a new section 6 to appropriate the sum of \$2,717,200 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding the Development Project Fund of the Federated States of Micronesia; to delete specific appropriations for development projects from the General Fund of the Federated States of Micronesia; to appropriate funds for development projects from the Development Project Fund of the Federated States of Micronesia; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 6 of Public Law No. 4-51, as established by 1 Public Law No. 4-88, is hereby repealed in its entirety and a new section 6 is hereby enacted to read as follows: 3 4 "Section 6. Appropriation to the Development Project Fund. 5 The sum of \$2,717,200 is hereby appropriated from the General Fund of the Federated States of Micronesia for the 6 7 fiscal year ending September 30, 1987, to support the 8 development projects of the National Government in fiscal year 1987 and all subsequent fiscal years. The funds 9 10 appropriated under this section shall be deemed to have 11 come from the capital account of the Compact of Free 12 Association." Section 2. The sum of \$741,000, or so much thereof as may be 13 14 necessary, is hereby appropriated from the Development Project Fund 15 of the Federated States of Micronesia for the fiscal year ending 16 September 30, 1987, for capital improvement/development projects 17 of the National Government of the Federated States of Micronesia 18 during fiscal year 1987. The sum appropriated by this section shall be apportioned as follows: 20 (1) Marine resources: 21 (a) Marine poisoning investigation... \$ 10,000 22 (b) Local catch statistics 23 project ..... 45,000
