AN ACT

To authorize the publishing of the First Supplement to the Code of the Federated States of Micronesia pursuant to contract with Book Publishing Company; to authorize a credit to the Federated States of Micronesia against the cost of publishing the First Supplement in the amount of \$85 for each two-volume set of the First Edition of the Code of the Federated States of Micronesia returned to Book Publishing Company; to appropriate the sum of \$3,912 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, to defray the costs of publication; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The publishing of the First Supplement to the Code of
- 2 the Federated States of Micronesia pursuant to contract with Book
- 3 Publishing Company is hereby authorized and the sum of \$3,912, or so
- 4 much thereof as may be necessary, is hereby appropriated from the
- 5 General Fund of the Federated States of Micronesia for the fiscal
- 6 year ending September 30, 1986, to defray the costs thereof. The
- 7 contract may authorize a credit to the Federated States of Micro-
- 8 nesia against the cost of publishing the First Supplement in the
- 9 amount of \$85 for each two-volume set of the First Edition of the
- 10 Code of the Federated States of Micronesia returned to Book Publish-
- 11 ing Company; PROVIDED that the contract shall not permit more than
- 12 150 sets of the First Edition of the Code of the Federated States
- 13 of Micronesia to be returned to Book Publishing Company.
- 14 Section 2. All funds appropriated by this act shall be
- 15 allotted, managed, administered, and accounted for in accordance
- 16 with applicable law, including, but not limited to, the Financial
- 17 Management Act of 1979. The allottee for the funds appropriated
- 18 under section 1 of this act shall be the President of the Federated
- 19 States of Micronesia. The allottee shall be responsible for
- 20 ensuring that these funds, or so much thereof as may be necessary,
- 21 are used solely for the purpose specified in this act, and that no
- 22 obligations are incurred in excess of the sum appropriated. The

2	shall remain effective until the funds are fully expended.
3	Section 3. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its becoming
