CONGRESSIONAL BILL NO. 4-244, C.D.1

## AN ACT

To further amend title 10 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 2-61 and 3-4, by adding a new chapter 4 concerning the Compact of Free Association, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Title 10 of the Code of the Federated States of
- 2 Micronesia is hereby further amended by adding a new section 401 of
- 3 chapter 4 to read as follows:
- 4 "Section 401. Definition. As used in this chapter,
- 5 'Compact' means the Compact of Free Association between the
- 6 Federated States of Micronesia and the United States of
- 7 America and its related agreements."
- 8 Section 2. Title 10 of the Code of the Federated States of
- 9 Micronesia is hereby further amended by adding a new section 402 of
- 10 chapter 4 to read as follows:

## "Section 402. Amendments to Compact.

- (1) Mutual agreement by the Government of the Federated States of Micronesia as provided for in the Compact which results in amendment thereof shall be effected only by a two-thirds vote of the Members of the Congress of the Federated States of Micronesia.
- 15 (2) Notwithstanding any other provision of this

  16 section, mutual agreement by the Government of the Federated

  17 States of Micronesia as provided for in the Compact which

  18 results in amendment thereof shall be effected only by a

  19 two-thirds vote of the Members of Congress and majority

  20 approval by the State legislatures of two-thirds of the

  21 States of the Federated States of Micronesia if such
- 22 amendment provides for:

1	(a) Delegation of a major power or major powers of
2	government of the Federated States of Micronesia to another
3	government; or
4	(b) Substantial reduction in any Compact benefit,
5	even if the reduction is accompanied by any form of
6	compensation.
7	(3) Notwithstanding any other provision of this
8	section, the Congress of the Federated States of Micronesia
9	may, as a matter of policy on a case-by-case basis, refrain
10	from acting upon an amendment not within the scope of
11	subsection (2) of this section until the State legislatures
12	have had an opportunity to express a formal opinion on the
13	matter by resolution."
14	Section 3. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its becoming
16	law without such approval.
