FOURTH REGULAR SESSION, 1986

CONGRESSIONAL BILL No. 4-331, C.D.1, C.D.2,
C.D.3, C.D.4

AN ACT

To appropriate the sum of \$1,700,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,700,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September 30,
4 1987, for the purpose of funding public projects in the State of Truk.

5 Section 2. The sum appropriated under section 1 of this act shall
6 be apportioned as follows:



11 Section 3. All funds appropriated by this act shall be allotted,
12 managed, administered, and accounted for in accordance with applicable
13 law, including, but not limited to, the Financial Management Act of
14 1979. Except for those funds appropriated under paragraphs (a), (b),
15 (c), and (d) of subsection (2) of section 2, paragraph (m) of subsection
16 (5) of section 2 and paragraphs (a), (b), (c), and (d) of subsection
17 (6) of section 2, the allottee shall be the Governor of the State of
18 Truk. The allottee for funds appropriated under paragraphs (a), (b),
19 (c), and (d) of subsection (2) of section 2 shall be the Northern
20 Namoneas Development Authority. The allottees for funds appropriated
21 under paragraph (m) of subsection (5) of section 2 shall be the
22 respective development authorities of the Mortlock Islands. The allottee
23 for funds appropriated under paragraph (a) of subsection (6) of section 2
24 shall be the Pattiw Development Authority. The allottee for funds
25 appropriated under paragraph (b) of subsection (6) of section 2 shall be

1 the Weito Development Authority. The allottee for funds appropriated
2 under paragraphs (c) and (d) of subsection (6) of section 2 shall be the
3 Hall Islands Development Authority. The allottees shall be responsible
4 for ensuring that these funds, or so much thereof as may be necessary,
5 are used solely for the purposes specified in this act, and that no
6 obligations are incurred in excess of the sum appropriated. The authority
7 of the allottees to obligate funds appropriated by this act shall remain
8 effective until funds are fully expended. The allottees shall make a
9 written report of the status of the funds appropriated hereunder to the
10 Congress of the Federated States of Micronesia during its October regular
11 session each year until such time as all funds are fully expended.

12 Section 4. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
