A BILL FOR AN ACT

To entitle the President and the Vice-President of the Federated States of Micronesia, the Speaker, the Vice Speaker, and the Floor Leader of the Congress of the Federated States of Micronesia, and the Chief Justice and Associate Justices of the Supreme Court of the Federated States of Micronesia to either Government-paid leased housing, or housing allowances in lieu of Government-paid leased housing, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. It is the intent of the Congress of the Federated States  
2 of Micronesia that the President and the Vice-President of the Federated  
3 States of Micronesia, the Speaker, the Vice Speaker, and the Floor Leader  
4 of the Congress of the Federated States of Micronesia, and the Chief  
5 Justice and the Associate Justices of the Supreme Court of the Federated  
6 States of Micronesia, by virtue of their respective positions within the  
7 Government of the Federated States of Micronesia, shall be entitled to  
8 either Government-paid leased housing, or housing allowances in lieu of  
9 Government-paid leased housing irrespective of their domiciliaries.

10 Section 2. Notwithstanding any provision of law to the contrary,  
11 the President and the Vice-President of the Federated States of Micronesia,  
12 the Speaker, the Vice Speaker, and the Floor Leader of the  
13 Congress of the Federated States of Micronesia, and the Chief Justice  
14 and Associate Justices of the Supreme Court of the Federated States of  
15 Micronesia are entitled to either Government-paid leased housing, or  
16 housing allowances in lieu of Government-paid leased housing in addition  
17 to whatever benefits to which they are currently entitled.

18 Section 3. Each of the beneficiaries of this act shall, at his  
19 own discretion, decide whether he shall receive Government-paid leased  
20 housing, or a housing allowance in lieu of Government-paid leased housing;  
21 PROVIDED that he may not receive both simultaneously. In the event that  
22 a beneficiary of this act decides to receive a housing allowance,  
23 instead of Government-paid leased housing, such beneficiary shall be  
24 entitled to receive an amount equal to, and not exceeding, the maximum  
25 housing allowance for employees of the National Government established

4 Section 4. This act shall become law upon approval by the President  
5 of the Federated States of Micronesia or upon its becoming law without
