A BILL FOR AN ACT

To appropriate the sum of \$230,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, for the purpose of funding public projects in the Mortlock Islands of the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$230,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the Federated  
3 States of Micronesia for the fiscal year ending September 30, 1986, for  
4 the purpose of funding public projects in the Mortlock Islands of the  
5 State of Truk.

6 Section 2. The sum appropriated under section 1 of this act shall  
7 be apportioned as follows:

- 8 (1) Kuttu public projects . . . . . \$25,000
- 9 (2) Moch public projects . . . . . 25,000
- 10 (3) Satawan public projects . . . . . 25,000
- 11 (4) Ta airport . . . . . 25,000
- 12 (5) Lukunoch public projects . . . . . 25,000
- 13 (6) Oneop public projects . . . . . 25,000
- 14 (7) Namoluli public projects . . . . . 25,000
- 15 (8) Ettal public projects . . . . . 25,000
- 16 (9) Pis public projects . . . . . 10,000
- 17 (10) Losap public projects . . . . . 10,000
- 18 (11) Nama public projects . . . . . 10,000

19 Section 3. All funds appropriated by this act shall be allotted,  
20 managed, administered, and accounted for in accordance with applicable  
21 law, including, but not limited to, the Financial Management Act of 1979.  
22 The allottees shall be the development authorities for the respective  
23 areas of the Mortlock Islands. The allottees shall be responsible for  
24 ensuring that these funds, or so much thereof as may be necessary, are  
25 used solely for the purposes specified in this act, and that no obligations

1 are incurred in excess of the sum appropriated. The authority of the  
2 allottees to obligate funds appropriated by this act shall remain effective  
3 until funds are fully expended. The allottees shall make a written report  
4 of the status of the funds appropriated hereunder to the Congress of the  
5 Federated States of Micronesia during its October regular session each  
6 year until such time as all funds are fully expended.

7 Section 4. This act shall become law upon approval by the President  
8 of the Federated States of Micronesia or upon its becoming law without  
9 such approval.
