A BILL FOR AN ACT

To appropriate the sum of \$475,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding public projects in Faichuk, State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$475,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1987, for
4 the purpose of funding public projects in Faichuk, State of Truk.

5 Section 2. The sum appropriated under section 1 of this act
6 shall be apportioned as follows:

5 Section 3. All funds appropriated by this act shall be allotted,
6 managed, administered, and accounted for in accordance with applicable
7 law, including, but not limited to, the Financial Management Act of
8 1979. The allottee for the funds apportioned under section 2 of this
9 act shall be the Governor of the State of Truk. The allottee shall be
10 responsible for ensuring that these funds, or so much thereof as may
11 be necessary, are used solely for the purposes specified in this act,
12 and that no obligations are incurred in excess of the sum appropriated.
13 The authority of the allottee to obligate funds appropriated by this
14 act shall lapse as of September 30, 1987.

15 Section 4. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its becoming
17 law without such approval.
