

A BILL FOR AN ACT

To further amend title 10 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 2-61, 3-4, and 4-66, by adding a new chapter 5 concerning the Foreign Affairs Advisory Council; to appropriate the sum of \$9,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding the travel necessary for Council meetings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 10 of the Code of the Federated States of
2 Micronesia is hereby further amended by adding a new section 501 of
3 chapter 5 to read as follows:

4 "Section 501. Foreign Affairs Advisory Council - Creation.
5 There is hereby created the Foreign Affairs Advisory
6 Council."

7 Section 2. Title 10 of the Code of the Federated States of
8 Micronesia is hereby further amended by adding a new section 502
9 of chapter 5 to read as follows:

10 "Section 502. Foreign Affairs Advisory Council - Meetings.
11 The Foreign Affairs Advisory Council shall meet with
12 officials from the Federated States of Micronesia
13 Department of External Affairs for the purpose of
14 consultations and exchanges of views. The Council shall
15 meet at times mutually agreed upon by the Council
16 and the Department."

17 Section 3. Title 10 of the Code of the Federated States of
18 Micronesia is hereby further amended by adding a new section 503
19 of chapter 5 to read as follows:

20 "Section 503. Foreign Affairs Advisory Council - Members.
21 The Foreign Affairs Advisory Council shall consist of one
22 member from each State of the Federated States of Micro-
23 nesia appointed jointly by the Governor and Speaker of the
24 State legislature of that State. Members shall serve at
25 the pleasure of their respective Governors, although if

1 a member is replaced the replacement must be by joint
2 appointment. If a member is unable to attend a meeting of
3 the Council, the Governor and Speaker may jointly appoint an
4 alternate to attend in his place."

5 Section 4. Title 10 of the Code of the Federated States of
6 Micronesia is hereby further amended by adding a new section 504 of
7 chapter 5 to read as follows:

8 "Section 504. Foreign Affairs Advisory Council - Expenses
9 and compensation. Members of the Foreign Affairs Advisory
10 Council shall be entitled to necessary travel expenses and to
11 per diem at standard Federated States of Micronesia rates
12 while on the business of the Council. Council members who
13 are neither employees nor officials of the National
14 Government of the Federated States of Micronesia or any
15 State government shall, in addition, be paid \$30 per day
16 while on the business of the Council. If a member of the
17 Council is concurrently employed in another post in the
18 Federated States of Micronesia National Government, he shall
19 be granted leave to attend meetings of the Council, and shall
20 receive his regular salary while on the business of the
21 Council."

22 Section 5. The sum of \$9,000, or so much thereof as may be
23 necessary, is hereby appropriated from the General Fund of the
24 Federated States of Micronesia for the fiscal year ending September
25 30, 1987, for the purpose of funding the travel necessary for Foreign

1 Affairs Advisory Council meetings.

2 Section 6. All funds appropriated by this act shall be
3 allotted, managed, administered, and accounted for in accordance with
4 applicable law, including, but not limited to, the Financial Manage-
5 ment Act of 1979. The allottee shall be responsible for ensuring
6 that these funds, or so much thereof as may be necessary, are used
7 solely for the purpose specified in this act, and that no obligations
8 are incurred in excess of the sum appropriated. The authority of the
9 allottee to obligate funds appropriated by this act shall lapse as of
10 September 30, 1987.

11 Section 7. This act shall become law upon approval by the
12 President of the Federated States of Micronesia or upon its becoming
13 law without such approval.
