A BILL FOR AN ACT

To further amend Public Law No. 3-56, as amended by Public Laws Nos. 3-71, 4-8, 4-14, and 4-49, by further amending section 1, as amended by Public Laws Nos. 3-71, 4-8, and 4-49, to change the purpose for which funds were appropriated under subsection (2)(h), and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-56, as amended by
2 Public Laws Nos. 3-71, 4-8, and 4-49, is hereby further amended to
3 read as follows:

4 "Section 1. The sum of \$789,700, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1985, for the purpose of funding
8 public projects in the State of Truk. The sum appropriated
9 herein shall be apportioned as follows:

 - 11 (a) Purchase of hospital medical
 - 12 supplies and equipment. \$ 20,000
 - 13 (b) Purchase of Truk
 - 14 dispensaries' medical supplies
 - 15 and equipment 10,000

 - 18 (d) Purchase of dental supplies
 - 19 and equipment 5,000
 - 20 (e) Purchase of a cargo and

 - 24 Authority (TOL) 8,500
 - 25 (g) Projects and operations funds


