A BILL FOR AN ACT

To amend Public Law No. 4-51, by amending sections 1, 2, and 7 for the purpose of appropriating the sum of \$78,000 from the General Fund of the Federated States of Micronesia and the sum of \$72,800 from the United States Grant Special Fund for the fiscal year ending September 30, 1987, as supplemental funding for the operations of the Department of Finance, Office of Public Information, and legislative branch; to increase employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 4-51 is hereby amended
2 to read as follows:

3 "Section 1. Operating expenses of the executive branch. The
4 sum of ~~\$1,346,000~~ 1,358,698, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia and the sum of ~~\$5,750,000~~
7 5,832,689, or so much thereof as may be necessary, is hereby
8 appropriated from the United States Grant Special Fund for
9 the fiscal year ending September 30, 1987, for the operations
10 of the executive branch of the National Government of the
11 Federated States of Micronesia during fiscal year 1987. The
12 sums appropriated by this section shall be apportioned as
13 follows:

 10 The sum of ~~\$1,839,898~~ 1,904,998, or so much thereof as may
 11 be necessary, is hereby appropriated from the General Fund
 12 of the Federated States of Micronesia for the fiscal year
 13 ending September 30, 1987, for the operations of the
 14 legislative branch of the National Government of the
 15 Federated States of Micronesia during fiscal year 1987.
 16 The sums appropriated by this section shall be apportioned
 17 as follows:



9 (2) The number of positions authorized applies
10 individually to each of the departments and offices of the
11 executive and legislative branches, the National judiciary,
12 the Public Auditor, and to the agencies as provided in
13 subsection (1) of this section, except that the President
14 may transfer up to 12 positions between the departments and
15 offices of the executive branch. This authorization of
16 positions covers all permanent employees, all contract
17 personnel whose employment extends for 1 year or more, and
18 all positions funded from United States federal programs.
19 No funds may be expended for unbudgeted positions."

20 Section 4. This act shall become law upon approval by the
21 President of the Federated States of Micronesia or upon its becoming
22 law without such approval.
