A RESOLUTION

Ratifying the "Inter-Departmental Support Agreement For The Utilization Of U.S. Military Civic Action Construction Teams In The Trust Territory Of The Pacific Islands, (Federated States of Micronesia and the Republic of Palau) for Fiscal Year 1983."

1 WHEREAS, an agreement styled as "Inter-Departmental Support
2 Agreement For The Utilization Of U.S. Military Civic
3 Action Construction Teams In The Trust Territory of the Pacific
4 Islands, (Federated States of Micronesia and the Republic of Palau)
5 for Fiscal Year 1983" has been proposed for the benefit of the
6 Federated States of Micronesia and the Republic of Palau; and

7 WHEREAS, said agreement has been executed by the United States
8 Navy Commander in Chief Pacific Representative Guam and the Trust
9 Territory of the Pacific Islands, the High Commissioner of the Trust
10 Territory of the Pacific Islands, and the President of the
11 Federated States of Micronesia; and

12 WHEREAS, said agreement sets forth the responsibilities and
13 procedures under which the United States Department of Defense
14 shall provide military civic action construction teams to the
15 Federated States of Micronesia for local small-scale public works
16 projects; and

17 WHEREAS, performance under said agreement will benefit the
18 people of the Federated States of Micronesia; and

19 WHEREAS, said agreement is an international agreement
20 requiring ratification by Congress in accordance with article IX,
21 section 4, of the Constitution of the Federated States of Micro-
22 nesia; and

23 WHEREAS, by a letter dated October 29, 1982, to the
24 Speaker of the Congress, the President of the Federated States of
25 Micronesia has recommended ratification of said agreement;



2 BE IT RESOLVED by the Second Congress of the Federated
3 States of Micronesia, Fourth Regular Session, 1982, that the
4 Congress hereby ratifies the "Inter-Departmental Support Agree-
5 ment For The Utilization Of U.S. Military Civic Action
6 Construction Teams In The Trust Territory Of The Pacific Islands,
7 (Federated States of Micronesia and the Republic of Palau) for
8 Fiscal Year 1983"; and

9 BE IT FURTHER RESOLVED that certified copies of this
10 resolution be transmitted to the President of the Federated
11 States of Micronesia, the High Commissioner of the Trust Territory
12 of the Pacific Islands, the President of the Republic of Palau,
13 and the United States Navy Commander in Chief Pacific
14 Representative Guam and the Trust Territory of the Pacific
15 Islands.
