A RESOLUTION

Endorsing Resolution No. 2-256, L.D.1, of the Second Kosrae State legislature, Sixth Regular Session, 1982, which expresses Kosrae's need and desire for air jet service by Air Nauru, and expressing the desire of the Congress of the Federated States of Micronesia to be fully informed of any plans Air Nauru may have to provide such service.

1           WHEREAS, the Congress of the Federated States of Micronesia has  
2 received from the Second Kosrae State Legislature Resolution No. 2-256,  
3 L.D.1, "A Resolution Expressing Kosrae's need and desire for air jet  
4 service by Air Nauru and requesting Air Nauru to inform the Legislature  
5 of what plans it may have for servicing Kosrae upon the completion  
6 of the new Kosrae airstrip."; a copy of which is attached hereto; and

7           WHEREAS, the Congress of the Federated States of Micronesia also  
8 recognizes the need for jet transportation service to Kosrae; and

9           WHEREAS, such air transportation service would be a major conven-  
10 ience to the people and government of not only Kosrae, but also the  
11 rest of the people and governments of the Federated States of Micronesia;  
12 and

13           WHEREAS, the existence or nonexistence of Air Nauru plans to extend  
14 air transportation service to Kosrae should be considered by the  
15 National Government of the Federated States of Micronesia in planning  
16 the improvement of air transportation service to Kosrae; now, therefore,

17           BE IT RESOLVED by the Second Congress of the Federated States of  
18 Micronesia, Fourth Regular Session, 1982, that the Congress hereby endorses  
19 Resolution No. 2-256, L.D.1, of the Second Kosrae State Legislature, Sixth  
20 Regular Session, 1982, expressing Kosrae's need and desire for air jet  
21 transportation service to Kosrae; and

22           BE IT FURTHER RESOLVED that Air Nauru be requested to provide the  
23 Congress of the Federated States of Micronesia complete information  
24 regarding any plans it may have regarding the extension of air

1 transportation services to Kosrae upon completion of the new Kosrae  
2 airstrip or the lack of such plans; and

3 BE IT FURTHER RESOLVED that certified copies of this resolution  
4 be transmitted to the President of the Republic of Nauru; the President  
5 of the Federated States of Micronesia; the Governor of the State of  
6 Kosrae; and the Speaker of the Kosrae State Legislature.
