## A BILL FOR AN ACT

To establish the Kitti and Madolenihmw Economic Development Board for the purpose of administering the Kitti Economic Development Revolving Loan Fund; to establish the Kitti Economic Development Revolving Loan Fund and the Madolenihmw Economic Development Revolving Loan Fund; to appropriate the sum of \$50,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding such development revolving funds for the benefit of those municipalities in the State of Pohnpei; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. <u>Purpose</u>. The purpose of this act is to establish
- 2 a Kitti Economic Development Revolving Loan Fund and a Madolenihmw
- 3 Economic Development Revolving Loan Fund for the purpose of promoting
- 4 economic development in those respective municipalities in the State
- 5 of Pohnpei and to provide for the administration of each of these
- 6 Funds.
- 7 Section 2. Definitions. As used herein, unless otherwise
- 8 indicated by context, the following definitions shall be applicable:
- 9 (1) "Board" means the Kitti and Madolenihmw Economic
- 10 Development Board;
- 11 (2) 'Fund' or 'Funds' means either or both the Kitti
- 12 Economic Development Revolving Loan Fund or the Madolenihmw
- 13 Economic Development Revolving Loan Fund established and funded
- 14 by this act; and
- 15 (3) 'Loan' means a loan of monies from either Fund
- 16 made pursuant to the provisions of this act for the purpose of
- 17 promoting economic development in the municipality from whose
- 18 Fund the loan proceeds are drawn.
- 19 Section 3. Kitti and Madolenihmw Economic Development Board -
- 20 Establishment and membership. There is hereby established the Kitti
- 21 and Madolenihmw Economic Development Board which shall consist of
- 22 the following three members:
- 23 (1) The Luhkenmenlap of Kitti Municipality;
- 24 (2) The Meninkeder Lapalap of Madolenihmw Municipality; and
- 25 (3) One member appointed by the representative of the

1 Kitti and Madolenihmw Municipalities in the Congress of the Federated States of Micronesia. 3 Section 4. Kitti and Madolenihmw Economic Development Board -Organization and compensation. 4 (1) The members of the Board shall establish rules of 5 organization and procedure which shall govern all operations, actions 6 and meetings of the Board. 7 (2) The members of the Board shall serve without 8 compensation. 9 Section 5. Kitti and Madolenihmw Economic Development Board -10 Duties and functions. The Board's duties and functions shall be as 11 12 follows: (1) The Board shall have full authority to award loans 13 out of the Kitti Economic Development Revolving Loan Fund and the Madolenihmw Economic Development Revolving Loan Fund for the purpose of promoting economic development in those respective municipalities; PROVIDED, however, that all loan recipents shall 17 be citizens of the Federated States of Micronesia or businesses 18

21 (2) The Board shall establish such eligibility criteria,

municipality from whose Fund the loan proceeds are drawn; and

duly chartered within the State of Pohnpei, resident in the respective

- 22 loan terms, disbursement procedures, and other rules, guidelines, or
- 23 conditions as may be necessary to administer the funds for the uses
- 24 contemplated by this act or to otherwise implement the provisions and
- 25 accomplish the purposes of this act.

1	Section 6. Appropriation.
2	(1) The sum of \$50,000, or so much thereof as may be
3	necessary, is hereby appropriated from the General Fund of the
4	Federated States of Micronesia for the fiscal year ending
5	September 30, 1989, for the purpose of funding Economic Development
6	Revolving Loan Funds for the Kitti and Madolenihmw Municipalities in
7	the State of Pohnpei. The funds appropriated by this act shall be
8	deemed to have come from the capital account of the Compact of Free
9	Association.
10	(2) The sum appropriated under subsection (1) of
11	section 6 of this act shall be apportioned as follows:
12	(a) Kitti - Economic Development
13	Revolving Loan Fund\$ 25,000
14	(b) Madolenihmw - Economic Development
15	Revolving Loan Fund
16	(3) All funds appropriated by this act shall be allotted,
17	managed, administered, and accounted for in accordance with applicable
18	law, including, but not limited to, the Financial Management Act of
19	1979. The allottee shall be the Kitti and Madolenihmw Economic
20	Development Board which shall be responsible for ensuring that these
21	funds, or so much thereof as may be necessary, are used solely for the
22	purposes specified in this act, and that no obligations are incurred
23	in excess of the sum appropriated. The authority of the allottee to
24	obligate funds appropriated by this act shall not lapse until
25	expended.
