To further amend sections 2 and 10 of Public Law No. 4-51, as amended by Public Law No. 4-88, to appropriate the sum of \$46,525 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the Congress of the Federated States of Micronesia; to increase the employment ceiling for Congress; and for other purposes.
