

Public Law No. 5 - 80

FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD SPECIAL SESSION, 1988 CONGRESSIONAL BILL No. 5-338, C.D.1, C.D.2

AN ACT

To appropriate the sum of \$430,330 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain public projects in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$430,330, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1989, for the purpose of funding certain public projects in the
5 State of Kosrae.

6 Section 2. The sum appropriated under section 1 of this act
7 shall be apportioned as follows:

12 Section 3. All funds appropriated by this act shall be allotted,
13 managed, administered, and accounted for in accordance with applicable
14 law, including, but not limited to, the Financial Management Act of
15 1979. The allottee of the funds appropriated under section 2 of this
16 act shall be the Governor of the State of Kosrae; except, however,
17 that the allottee of the funds appropriated under sub-paragraphs (1),
18 (2)(a), (2)(b), (2)(d), (2)(e), (2)(f), (2)(g), (3)(a), (3)(b),
19 (3)(c), (3)(e), (3)(f), (3)(g), (3)(h), (3)(i), (4) and (5) of section
20 2 of this act shall be the Chairman of the Kosrae Small Improvement
21 Projects Commission, and the allottee of the funds appropriated
22 under sub-paragraphs (2)(c), (3)(d), (6), (7), (11), and (12) of
23 section 2 of this act shall be the Chairman of the Kosrae
24 Congressional Delegation. Each allottee shall be responsible for
25 ensuring that these funds, or so much thereof as may be necessary,

1 are used solely for the purposes specified in this act, and that no
2 obligations are incurred in excess of the sum appropriated. The
3 authority of the allottees to obligate funds appropriated by this act
4 shall not lapse until expended.

5 Section 4. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its becoming
7 law without such approval.


