A RESOLUTION

Respectfully requesting that the appropriate officials in the National Government of the Federated States of Micronesia raise the issue of the interpretation of paragraph 8 of Article VI of the Federal Programs and Services Agreement Concluded Pursuant to Article II of Title Two and Section 232 of the Compact of Free Association in consultations with appropriate officials from the Government of the United States, and that they report the results of these consultations to the Congress prior to the commencement of the next Congress session.

- WHEREAS, paragraph 8 of Article VI of the Federal Programs and
- 2 Services Agreement Concluded Pursuant to Article II of Title Two and
- 3 Section 232 of the Compact of Free Association provides in pertinent
- 4 part that the United States Postal Service shall convey mail "to and
- 5 from the designated exchange offices in . . . the Federated States of
- 6 Micronesia"; and
- WHEREAS, it is the sense of the Congress that it is the position
- 8 of the National Government of the Federated States of Micronesia that
- 9 the phrase "designated exchange offices" refers to the four post offices
- 10 operating in the Federated States of Micronesia; and
- 11 WHEREAS, the United States Government has recently taken the
- 12 position that the phrase "designated exchange offices" refers to
- 13 ports of entry, such as airports and docks, within the Federated States
- 14 of Micronesia; and
- 15 WHEREAS, this disagreement over the interpretation of the above-
- 16 quoted portion of paragraph 8 could have serious consequences relating
- 17 to such issues as liability if valuable parcels are lost, stolen, or
- 18 damaged while in transit between a post office and a port of entry
- 19 in the Federated States of Micronesia; now, therefore,
- 20 BE IT RESOLVED by the Fifth Congress of the Federated States of
- 21 Micronesia, First Regular Session, 1987, that the Congress hereby
- 22 respectfully requests that the appropriate officials in the National
- 23 Government of the Federated States of Micronesia raise the issue of the
- 24 interpretation of paragraph 8 of Article VI of the Federal Programs and
- 25 Services Agreement Concluded Pursuant to Article II of Title Two and

14	States of Micronesia.
