A BILL FOR AN ACT

To further amend Public Law No. 4-28, Truk State public projects, as amended, by further amending section 3, as amended by Public Laws Nos. 4-43 and 4-64, for the purpose of changing the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1	. Section 3 of Public Law No. 4-28, as amended by Public

8	shal	l be the Truk Lagoon radio association. The allottee
9	of f	unds appropriated under subsection (1)(j) of section 2
10	shal	1 be the chairman of the Truk congressional delegation.
11	The	allottee of funds appropriated under subsections
12	(9)	by/ (9)(4)/ And (9)(4) of section 2 shall be the
13	Gove	rnor of Truk State. The other allottees shall be the
14	deve	elopment authorities for the respective areas of Truk
15	Stat	e. The allottees shall be responsible for ensuring
16	5 that	these funds, or so much thereof as may be necessary,
17	7 are	used solely for the purposes specified in this act, and
18	3 that	no obligations are incurred in excess of the sum
19	appi	copriated. The authority of the allottees to obligate
20) fund	ds appropriated by this act shall remain effective until
21	1 fund	ds are fully expended. The allottees shall make a
22	2 wri	tten report of the status of the funds appropriated
23	3 here	eunder to the Congress of the Federated States of
24	4 Mic	ronesia during its October regular session each year
25	5 unt	il such time as all funds are fully expended."
