## A BILL FOR AN ACT

To amend title 37 of the Code of the Federated States of Micronesia by adding a new chapter 1 for the purpose of establishing a National Government vehicle self-insurance program, the National Government Self-Insurance Fund, to appropriate the sum of \$250,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990 to capitalize the Self-Insurance Fund, and for other

	urposes.
	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Title 37 of the Code of the Federated States of
2	Micronesia is hereby amended by adding a new chapter I entitled
3	"Official Vehicle Insurance Plan."
4	Section 2. Title 37 of the Code of the Federated States of
5	Micronesia is hereby amended by adding a new subchapter I of chapter
6	1 entitled "General Provisions."
7	Section 3. Title 37 of the Code of the Federated States of
8	Micronesia is hereby amended by adding a new section 101 of
9	subchapter I of chapter 1 to read as follows:
10	"Section 101. Purpose. The purpose of this chapter is to
11	establish a single self-insurance plan for all National
12	Government entities, to be administered jointly by the
13	Office of Administrative Services and the Department of

1 1 Finance of the Federated States of Micronesia, for the 14 payment of claims for accidental physical damage or loss, 15 or liability, incurred by such entities in connection with 16 the operation of official vehicles." 17 Section 4. Title 37 of the Code of the Federated States of 18 Micronesia is hereby amended by adding a new section 102 of 19 subchapter I of chapter 1 to read as follows: 20 "Section 102. Definitions. As used in this chapter, 21

17	(4) 'Director of OAS' means the Director of the
18	Office of Administrative Services of the National
19	Government of the Federated States of Micronesia.
20	(5) 'Insurance fund' means the National Government
21	Self-Insurance Fund established pursuant to section 108 of
22	this chapter.
23	(6) 'National Government' means the National
24	Government of the Federated States of Micronesia.
25	(7) 'National Government entity' means any branch,

1	department, office, or agency of the National Government of
2	the Federated States of Micronesia or any public
3	corporation.
4	(8) 'Official vehicle' means any vehicle owned by the
5	National Government of the Federated States of Micronesia
6	and registered with the Director of OAS.
7	(9) 'Payment of claim' means payment of a claim
8	arising under section 201 of this chapter and shall include
9	payment of a settlement or judgment arising from a court
10	proceeding involving such a claim.
11	(10) 'Plan' means the plan of official vehicle
12	collision, damage and liability insurance established by
13	this chapter.
14	(11) 'Secretary of Finance' means the Secretary of
15	Finance of the National Government of the Federated States
16	of Micronesia."
17	Section 5. Title 37 of the Code of the Federated States of
18	Micronesia is hereby amended by adding a new section 103 of
19	subchapter I of chapter 1 to read as follows:
20	"Section 103. Official Vehicle Insurance Plan - Powers of
21	the Director of OAS. The Director of OAS shall be
22	authorized to:
23	(1) Enter into, execute and perform such contracts,
24	leases, or other transactions as may be necessary in the
25	conduct of the business of the Official Vehicle Insurance

1	Plan and on such terms as he may deem appropriate;
2	(2) Determine the character of and the necessity for
3	obligations and expenditures in connection with the
4	Official Vehicle Insurance Plan and the manner in which
5	they shall be incurred; and
6	(3) Take such other actions as may be necessary
7	or appropriate to administer and manage the insurance
8	of covered property as required pursuant to this
9	chapter."
10	Section 6. Title 37 of the Code of the Federated States of
11	Micronesia is hereby amended by adding a new section 104 of
12	subchapter I of chapter 1 to read as follows:
13	"Section 104. Official Vehicle Insurance Plan - Powers of
14	the Secretary of Finance. The Secretary of Finance shall
15	be authorized to:
16	(1) Administer, manage, account for, deal with and
17	invest the Insurance Fund;
18	(2) Buy, sell, hold for investment, and deal in
19	securities of every description including mortgages, bonds,
20	debentures, promissory notes, commercial paper, and
21	securities of other classes;
22	(3) Execute all instruments necessary or appropriate
23	in the exercise of any of his powers in connection with the
24	Official Vehicle Insurance Plan;
25	(4) Pay claims, the costs of administration of the

7	Section 7. Title 37 of the Code of the Federated States of
8	Micronesia is hereby amended by adding a new section 105 of
9	subchapter I of chapter 1 to read as follows:
10	"Section 105. Official Vehicle Insurance Plan - Duties and
11	responsibilities of the Director of OAS. The Director of
12	OAS shall do all of the following:
13	(1) Establish terms, conditions and minimum standards,
14	consistent with the provisions of this chapter, for coverage
15	and participation in the program, including standards for
16	risk management and loss control;
17	(2) Establish acceptable classes of covered property;
18	(3) Establish terms and procedures for the processing
19	of claims made under the program;
20	(4) Determine and assess the validity of claims
21	submitted to the Director of OAS for payment;
22	(5) Investigate and engage reasonable sources for
23	reinsurance;
24	(6) Defend claims under the program, as necessary;
25	(7) Request the Secretary of Finance to pay claims,

5	(8) Develop, promulgate, and effectuate loss
6	prevention programs, risk management programs, and safety
7	programs; and
8	(9) Operate the Plan on an actuarially sound
9	basis so as to become neither more nor less than self-
10	supporting. For that purpose, loss experience and
11	expense shall be ascertained and credits, refunds, and
12	assessments may be made as determined appropriate by the
13	Director of OAS."
14	Section 8. Title 37 of the Code of the Federated States of
15	Micronesia is hereby amended by adding a new section 106 of
16	subchapter I of chapter 1 to read as follows:
17	"Section 106. Official Vehicle Insurance Plan - Duties and
18	responsibilities of the Secretary of Finance. The
19	Secretary of Finance shall do all of the following:
20	(1) Pay claims, the costs of administration of the
21	Plan or any other costs for the purposes specified or
22	authorized pursuant to this chapter from the National
23	Government Self-Insurance Fund;
24	(2) Invest or cause to be invested the Insurance Fund
25	pursuant to the standards of the National investment

5	Section 9. Title 37 of the Code of the Federated States of
6	Micronesia is hereby amended by adding a new section 107 of
7	subchapter I of chapter 1 to read as follows:
8	"Section 107. Official Vehicle Insurance Plan - Report.
9	By December 1 of each year, the Director of OAS and the
10	Secretary of Finance shall jointly transmit to the
11	President and the Congress of the Federated States of
12	Micronesia a report generally stating the activities
13	carried out in connection with the Plan and setting forth
14	the status of the Insurance Fund as of the close of the
15	fiscal year. Such report shall include audited financial
16	statements, a 3 year financial history, and a 5 year
17	financial forecast."
18	Section 10. Title 37 of the Code of the Federated States of
19	Micronesia is hereby amended by adding a new section 108 of
20	subchapter I of chapter 1 to read as follows:
21	"Section 108. National Government Self-Insurance Fund -
22	Establishment. There is hereby created and established
23	a National Government Self-Insurance Fund, hereinafter the
24	'Insurance Fund,' which shall be separate from the General
25	Fund of the Federated States of Micronesia and all other

1	funds. All sums appropriated by the Congress of the
2	Federated States of Micronesia representing contributions
3	of the National Government to the plan, all sums
4	representing contributions of public corporations or other
5	National Government entities to the plan, all earnings
6	accrued on the investment of the Insurance Fund, and
7	all earnings, revenues and other receipts collected in
8	connection with the plan shall be deposited into the
9	Insurance Fund. Moneys available in the Insurance Fund
10	shall be withdrawn by the Secretary of Finance for the
11	purposes specified or authorized pursuant to this chapter.
12	Any unexpended money in the Insurance Fund shall not revert
13	to the General Fund nor lapse at the end of a fiscal year
14	but shall remain in the Insurance Fund."
15	Section 11. Title 37 of the Code of the Federated States of
16	Micronesia is hereby amended by adding a new section 109 of
17	subchapter I of chapter 1 to read as follows:
18	"Section 109. Administration. The Insurance Fund shall be
19	allotted, managed, administered, and accounted for by the
20	Secretary of Finance of the National Government of the
21	Federated States of Micronesia, in accordance with
22	applicable law, including, but not limited to, the
23	Financial Management Act of 1979, as amended."
24	Section 12. Title 37 of the Code of the Federated States of
25	Micronesia is hereby amended by adding a new subchapter II of chapter

2	Section 13. Title 37 of the Code of the Federated States of
3	Micronesia is hereby amended by adding a new section 201 of
4	subchapter II of chapter 1 to read as follows:
5	"Section 201. Insurance of official vehicles - Eligible
6	claims.
7	(1) The Director of OAS will request the Secretary of
8	Finance to pay those sums that he determines are actual and
9	valid claims for loss, damage or indemnification arising
10	out of or as the result of:
11	(a) Any direct and accidental loss of, or damage
12	to, any official vehicle; and
13	(b) Any liability of a National Government
14	entity, or of an official or employee of any National
15	Government entity, for all sums which it or he shall become
16	legally obligated to pay as damages because of bodily
17	injury sustained by any person, or because of injury to or
18	destruction of property, caused by accident and arising out
19	of the National Government's ownership, maintenance or use
20	of an official vehicle; subject to more specific terms,
21	conditions and limitations as the Director of OAS may
22	establish.
23	(2) Notwithstanding the provisions of subsection (1)
24	of this section, the program shall not cover, nor shall any
25	payments thereunder be made for claims arising out of or in

2	(a) The unauthorized operation of an official
3	vehicle;
4	(b) The use of an official vehicle other than in
5	the course of official National Government business;
6	(c) Any intentional, dishonest, fraudulent,
7	criminally malicious or knowingly wrongful acts, errors or
8	omissions committed by, at the direction of, or with the
9	knowledge or acquiescence of the covered National
10	Government entity or its officers or employees; or
11	(d) Any criminal conduct committed by persons
12	for whom the National Government entity or its officers or
13	employees are legally liable."
14	Section 14. Title 37 of the Code of the Federated States of
15	Micronesia is hereby amended by adding a new section 202 of
16	subchapter II of chapter 1 to read as follows:
17	"Section 202. Covered property; Eligible participants.
18	(1) All official vehicles shall be covered under the
19	plan.
20	(2) A National Government entity may request coverage
21	for its officers or employees under the program and shall
22	be covered; PROVIDED, however, that they meet all standards
23	established by the Director of OAS for coverage under the
24	program. No National Government entity may be denied
25	coverage unless the Director of OAS determines that the

2	Section 15. Title 37 of the Code of the Federated States of
3	Micronesia is hereby amended by adding a new section 203 of
4	subchapter II of chapter 1 to read as follows:
5	"Section 203. Extent of coverage. The Director of OAS may
6	only cover risks to the extent that liability for:
7	(1) Physical damage or loss to an official vehicle
8	on any one occurrence is greater than \$200 but does not
9	exceed the replacement value of the vehicle; and
10	(2) Indemnification of a National Government entity,
11	or any of such entity's officials or employees, on any one
12	occurrence exceeds \$1,000 but does not exceed coverage
13	for any amount of liability on any one occurrence which
14	exceeds \$12,000."
15	Section 16. Title 37 of the Code of the Federated States of
16	Micronesia is hereby amended by adding a new section 204 of
17	subchapter II of chapter 1 to read as follows:
18	"Section 204. Plan contributions. No National Government
19	entity shall be required to pay a premium for coverage
20	under the plan; however, an assessment for extraordinary
21	contributions may be levied, from time to time as
22	necessary, upon public corporations or may be made by the
23	National Government; PROVIDED, however, that all such
24	contributions shall be based upon all appropriate actuarial
25	data, including, but not limited to, claims and loss

2	Section 17. Title 37 of the Code of the Federated States of
3	Micronesia is hereby amended by adding a new section 205 of
4	subchapter II of chapter 1 to read as follows:
5	"Section 205. Payment of Claims; Disposition of Insurance
6	Fund. All money deposited in the Insurance Fund shall be
7	used solely to pay claims for covered events under the
8	plan, except that a sum representing not more than five
9	percent of the balance of the Fund at the end of the
10	preceding fiscal year may be expended for administrative
11	costs. For the fiscal year ending September 30, 1990, the
12	sum expended for administrative costs shall not exceed
13	\$12,500."
14	Section 18. The sum of \$250,000, or so much thereof as may be
15	necessary, is hereby appropriated from the General Fund of the
16	Federated States of Micronesia for the fiscal year ending September
17	30, 1990, for the purpose of capitalizing the National Government
18	Self-Insurance Fund.
19	Section 19. This act shall become law upon approval by the
20	President of the Federated States of Micronesia or upon its becoming
21	law without such approval.
