## A BILL FOR AN ACT

To further amend Public Law No. 5-80, as amended by Public Laws Nos. 5-108 and 6-34, by further amending section 3, as amended by Public Law No. 6-34, for the purpose of changing the allottees of funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 5-80, as amended by
2	Public Law No. 6-34, is hereby further amended to read as follows:
3	"Section 3. All funds appropriated by this act shall be
4	allotted, managed, administered, and accounted for in
5	accordance with applicable law, including, but not limited
6	to, the Financial Management Act of 1979. The allottee of
7	the funds appropriated under section 2 of this act shall be
8	the Governor of the State of Kosrae; except, however, that
9	the allottee of the funds appropriated under sub-paragraphs
10	(1), $(2)(a)$ , $(2)(b)$ , $(2)(g)$ , $(3)(a)$ , $(3)(c)$ , $(3)(h)$ ,
11	(3)(i), $(4)(a)$ , $(4)(b)$ , $(4)(f)$ , $(4)(g)$ , $(5)(b)$ and $(5)(d)$
12	of section 2 of this act shall be the Chairman of the
13	Kosrae Small Improvement Projects Commission, and the
14	allottee of the funds appropriated under sub-paragraphs
15	(2)(c), (2)(d), (2)(e), (2)(f), (2)(h), (3)(b), (3)(d),
1.6	(3)(e), (3)(f), (3)(g), (4)(c), (4)(d), (4)(e), (5)(a),
17	(5)(c), (6), (7), (11), and (12) of section 2 of this act
18	shall be the President of the Federated States of
19	Micronesia or his designee. Each allottee shall be
20	responsible for ensuring that these funds, or so much
21	thereof as may be necessary, are used solely for the
22	purposes specified in this act, and that no obligations are
23	incurred in excess of the sum appropriated. The authority
24	of the allottees to obligate funds appropriated by this act
25	shall not lapse until expended."
