## A BILL FOR AN ACT

To further amend Public Law No. 6-10, as amended by Public Laws Nos. 6-43 and 6-46, by further amending section 2, as amended by Public Law No. 6-46, for the purpose of appropriating the sum of \$132,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the legislative branch, and for other purposes.
