A BILL FOR AN ACT

To further amend title 24 of the Code of the Federated States of Micronesia, as amended, by amending sections 402, 507 and 510 and by further amending title 55 of the Code of the Federated States of Micronesia, as amended, for the purpose of establishing, and authorizing the deposit of certain funds in, the Special Fisheries Development Loan Fund and the Special Marine Surveillance Revolving Fund, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. This act may be cited as the "Fishing Fees and Fines Act of 1990." 2 Section 2. Section 402 of title 24 of the Code of the Federated 3 States of Micronesia, as amended by Public Law No. 6-11, is hereby further amended to read as follows: "Section 402. Fees for foreign fishing permits. Fees and 6 other forms of compensation for the right to exploit marine resources within the exclusive economic zone by foreign 8 fishing vessels shall be established in foreign fishing 9 agreements entered into pursuant to sections 401, 404 and 10 405 of this title. One-half of such fees shall be 11 deposited in the General Fund of the Federated States of 12
- Micronesia, and the other half shall be deposited in the 13 Special Fisheries Development Loan Fund." 14
- Section 3. Section 507 of title 24 of the Code of the Federated 15 States of Micronesia, as amended by Public Law No. 6-11, is hereby further amended to read as follows:
- "Section 507. Forfeitures Disposition of property. The 18 forfeited vessel, gear, furniture, appurtenances, stores, 19 cargo, and fish may be sold and the proceeds deposited into 20 the General Fund of the Federated States of Micronesia and 21 distributed in accordance with section 510 of this title." 22
- Section 4. Section 510 of title 24 of the Code of the Federated 23
- States of Micronesia is hereby amended to read as follows: 24
- "Section 510. Revenue from fines and forfeitures. All 25

1	fines and the proceeds of sale of all forfeitures collected
2	pursuant to the provisions of this title shall be deposited
3	into the General Fund of the Federated States of
4	Micronesia. Fifty percent of these revenues from fines and
5	forfeitures shall then be distributed to the State
6	affected. Twenty-five percent shall be deposited in the
7	Special Marine Surveillance Revolving Fund, and the
8	remaining twenty-five percent shall be available for
9	appropriation by the Congress."
10	Section 5. Title 55 of the Code of the Federated States of
11	Micronesia is hereby further amended by adding a subchapter VI of
12	chapter 6 entitled "Special Fisheries Development Loan Fund."
13	Section 6. Title 55 of the Code of the Federated States of
14	Micronesia is hereby further amended by adding a new section 630 of
15	subchapter VI of chapter 6 to read as follows:
16	"Section 630. Establishment. There is hereby created and
17	established the Special Fisheries Development Loan Fund,
18 .	referred to in this subchapter as the 'Fund,' separate from
19	the General Fund of the Federated States of Micronesia and
20	all other funds."
21	Section 7. Title 55 of the Code of the Federated States of
22	Micronesia is hereby further amended by adding a new section 631 of
23	subchapter VI of chapter 6 to read as follows:
24	"Section 631. Purpose. The purpose of the Fund is to
25	promote fisheries development in the Federated States of

1	Micronesia by making low-interest loans to FSM citizens,
2	FSM businesses, governmental agencies and FSM State public
3	corporations, for the purpose of funding fisheries
4	demonstration projects or commercially-feasible fisheries
5	projects."
6	Section 8. Title 55 of the Code of the Federated States of
7	Micronesia is hereby further amended by adding a new section 632 of
8	subchapter VI of chapter 6 to read as follows:
9	"Section 632. Deposits. All future appropriations for the
10	Fund, as well as revenues for the Fund received from
11	fishing fees collected pursuant to section 402 of title 24
12	of the Code of the Federated States of Micronesia, all
13	payments from loans made by the Fund, and any income of the
14	Fund, shall be deposited in the Fund. Any unexpended
15	moneys in the Fund shall not revert to the General Fund nor
16	lapse at the end of the fiscal year."
17	Section 9. Title 55 of the Code of the Federated States of
18	Micronesia is hereby further amended by adding a new section 633 of
19	subchapter VI of chapter 6 to read as follows:
20	"Section 633. Administration. The Fund shall be
21	administered by the President of the Federated States of
22	Micronesia Development Bank or his designee, who shall
23	establish regulations or procedures necessary for the
24	effectuation and implementation of the provisions of this
25	subchapter in the same manner as is provided in title 30 of

1	the Code of the Federated States of Micronesia. The
1	Financial Management Act shall not apply to loans made from
2	the Fund nor to the reasonable administrative expenses
3	incurred in connection with the Fund. The Federated States
4	of Micronesia Development Bank shall be entitled to receive
5	reasonable expenses, not to exceed ten percent of the
6	Fund's income from interest and investment, for
7	administering the Fund."
8	Section 10. Title 55 of the Code of the Federated States of
9	Micronesia is hereby further amended by adding a new section 634 of
10	subchapter VI of chapter 6 to read as follows:
11	"Section 634. Annual report. The President of the
12	Federated States of Micronesia Development Bank or his
13	designee shall report to the Congress of the Federated
14	States of Micronesia on the status of the Fund at the close
15	of each fiscal year. Such report shall include an audited
16	income statement and balance sheet."
17	Section 11. Title 55 of the Code of the Federated States of
18	Micronesia is hereby further amended by adding a new subchapter VII
19	of chapter 6 entitled "Special Marine Surveillance Revolving Fund."

7	"Section 636. Purpose. The purpose of the Fund is to pay
8	for operational and maintenance costs associated with the
9	Marine Surveillance Program."
10	Section 14. Title 55 of the Code of the Federated States of
11	Micronesia is hereby further amended by adding a new section 637 of
12	subchapter VII of chapter 6 to read as follows:
13	"Section 637. Deposits. All future appropriations for the
14	Fund and all revenues for the Fund received from fines and
15	forfeitures under title 24 of the Code of the Federated
16	States of Micronesia shall be deposited in the Fund. Any
17	unexpended moneys in the Fund shall not revert to the
18	General Fund nor lapse at the end of the fiscal year."
19	Section 15. Title 55 of the Code of the Federated States of
20	Micronesia is hereby further amended by adding a new section 638 of
21	subchapter VII of chapter 6 to read as follows:
22	"Section 638. Administration. The Fund shall be
23	administered by the President of the Federated States of
24	Micronesia or his designee, who shall establish regulations
25	and procedures necessary and appropriate for the

1	effectuation and implementation of this subchapter,
2	pursuant to chapter 1 of title 17 of the Code of the
3	Federated States of Micronesia."
4	Section 16. Title 55 of the Code of the Federated States of
5	Micronesia is hereby further amended by adding a new section 639 of
6	subchapter VII of chapter 6 to read as follows:
7	"Section 639. Annual report, The President or his
8	designee shall report to the Congress of the Federated
9	States of Micronesia on the status of the Fund at the close
10	of each fiscal year,"
11	Section 17. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
