A BILL FOR AN ACT

To amend title 36 of the Code of the Federated States of Micronesia by repealing sections 101, 102, 103, 104, 105, 106, 107, 201, 202, 203, and 206 and by adding new sections 101, 102, and 201 to authorize the establishment of public corporations of the Federated States of Micronesia, to provide for existing corporations, and to create the position of Registrar of Corporations, by renumbering sections 204 and 205, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Sections 101, 102, 103, 104, 105, 106, 107, 201,
- 2 202, 203, and 206 of title 36 of the Code of the Federated States of
- 3 Micronesia are hereby repealed.
- 4 Section 2. Title 36 of the Code of the Federated States of
- 5 Micronesia is hereby amended by adding a new section 101 to
- 6 read as follows:
- 7 "Section 101. Public corporations. Public corporations of
- 8 the Federated States of Micronesia may be established by
- 9 law and shall not be subject to registration requirements
- of any State law."
- 11 Section 3. Title 36 of the Code of the Federated States of
- 12 Micronesia is hereby amended by adding a new section 102 to
- 13 read as follows:
- 14 "Section 102. Existing corporations. Corporate charters
- authorizing the existence of corporations heretofore formed
- or existing shall not be affected by the enactment of this
- act nor by repeal of the laws under which they were formed
- or created."
- 19 Section 4. Title 36 of the Code of the Federated States of
- 20 Micronesia is hereby amended by adding a new section 201 to
- 21 read as follows:
- 22 "Section 201. Registrar of Corporations. There shall be
- in the Department of Resources and Development a Registrar
- of Corporations appointed by the President of the Federated
- 25 States of Micronesia. The Registrar of Corporations shall

4	Section 5. Sections 204 and 205 of title 36 of the Code of
5	the Federated States of Micronesia are hereby renumbered as sections
6	202 and 203.
7	Section 6. This act shall become effective 90 days after it
8	becomes law.
9	Section 7. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its becoming
11	law without such approval.
