Public Law No. 6 - 103

AN ACT

To amend Public Law No. 6-91 by amending sections 1, 2, 5, 7 and 13 for the purpose of appropriating the sum of \$1,094,918 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991, as supplemental funding for operating expenses of the executive branch, legislative branch, agencies of the National Government, marine surveillance program, for administration of projects, and for development projects, and for the purpose of reprogramming certain funds previously appropriated for the legislative branch; by amending section 16 for the purpose of modifying employment ceilings; by renumbering section 19; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-91 is hereby amended to
2 read as follows:

3 "Section 1. Operating expenses of the executive branch.

4 The sum of \$9,711,679, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1991, for the operations of the
8 executive branch of the National Government of the
9 Federated States of Micronesia during fiscal year 1991.

10 As required by Public Law No. 5-119, the Congress of the
11 Federated States of Micronesia hereby declares that the
12 funding appropriated by this section is deemed to be
13 essential. The sum appropriated by this section shall
14 be apportioned as follows:


