8	obligations are incurred in excess of the sum appropriated.
9	The authority of the allottees to obligate funds appro-
10	priated by this act shall not lapse until expended."
11	Section 3. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
