THIRD REGULAR SESSION, 1990

CONGRESSIONAL BILL NO. 6-222, C.D.1, C.D.2

AN ACT

To further amend Public Law No. 6-10, as amended by Public Laws Nos. 6-43 and 6-46, by further amending sections 1, 5, 7 and 12, as amended by Public Law No. 6-43, for the purpose of appropriating the sum of \$459,590 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the executive branch, agencies of the National Government, and the Marine Surveillance Program; by amending section 14 for the purpose of modifying employment ceilings; to reprogram the funding of the National Fisheries Corporation from section 4 to section 12; by amending section 16 for the purpose of modifying lapse dates; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 6-10, as amended by Public Law No. 6-43, is hereby further amended to read as follows:

"Section 1. Operating expenses of the executive branch.

The sum of \$9,206,845, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the operations of the executive branch of the National Government of the Federated States of Micronesia during fiscal year 1990. As required by Public Law No. 5-119, the Congress of the Federated States of Micronesia hereby declares that the funding appropriated by this section is deemed to be essential. The sum appropriated by this section shall be apportioned as follows:

 15 thereof as may be necessary, is hereby appropriated from the
 16 General Fund of the Federated States of Micronesia for the
 17 fiscal year ending September 30, 1990, for the operations of
 18 independent agencies, commissions, authorities, boards, bureaus,
 19 and other organizations of the National Government of the
 20 Federated States of Micronesia during fiscal year 1990. As
 21 required by Public Law No. 5-119, the Congress of the Federated
 22 States of Micronesia hereby declares that the funding
 23 appropriated by subsections (1) and (5) of this section
 24 is deemed to be essential. The sum appropriated by this section

6 Section 6. Section 16 of Public Law No. 6-10, as amended by
7 Public Law No. 6-43, is hereby further amended to read as follows:

8 "Section 16. Allotment and management of funds and lapse
9 date. All funds appropriated by this act shall be
10 allotted, managed, administered, and accounted for in
11 accordance with applicable law, including, but not limited
12 to, the Financial Management Act of 1979, as amended;
13 PROVIDED, however, that the allottee of the funds
14 appropriated under subparagraphs (d) and (e) of subsection
15 (1) of section 1 of this act shall be the President and
16 such authority may not be delegated; PROVIDED FURTHER, that
17 the allottees for funds appropriated under subparagraph (m)
18 of subsection (2) of section 12 of this act shall be the
19 Governors of the respective States and that those funds
20 shall not be disbursed from the General Fund to the
21 allottee unless the President certifies that the State
22 involved has entered into a joint law enforcement agreement
23 for the period of October 1, 1989 to September 30, 1990,
24 with the National Government pursuant to chapter 12 of
25 title 12 of the Code of the Federated States of Micronesia.



1 Each allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purposes specified in this act, and that no
4 obligations are incurred in excess of the sum appropriated.
5 The authority of the allottees to obligate funds
6 appropriated by this act shall lapse as of September 30,
7 1990; PROVIDED, however, that the authority of the allottees
8 to obligate funds appropriated by sections 6, 7, 9, 10,
9 12(2)(p), 12(2)(q) and 13 shall not lapse."

10 Section 7. This act shall become law upon approval by the
11 President of the Federated States of Micronesia or upon its becoming
12 law without such approval.
