## AN ACT

To further amend Public Law No. 5-87, Yap State public projects, as amended by Public Law No. 6-18, by amending sections 1 and 2 and by further amending section 3, as amended by Public Law No. 6-18, to modify the use of funds, to remove the lapse date, to remove references to vetoed projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 5-87 is hereby amended to 1 read as follows: 2

"Section 1. The sum of \$20,000, or so much thereof as may 3 be necessary, is hereby appropriated from the General Fund 4 of the Federated States of Micronesia for the fiscal year 5 ending September 30, 1989, for the purpose of funding a 6 certain public project in the State of Yap. The funds 7 appropriated by this act shall be deemed to have come from the capital account of the Compact of Free Association." 9 Section 2. Section 2 of Public Law No. 5-87 is hereby amended to 10 read as follows: 11 "Section 2. The sum appropriated under section 1 of this act 12 shall be apportioned as follows: 13 (1) Piggery production project ..... \$ 20,000" 14 Section 3. Section 3 of Public Law No. 5-87, as amended by 15 Public Law No. 6-18, is hereby further amended to read as follows: 16 "Section 3. All funds appropriated by this act shall be 17 18 allotted, managed, administered, and accounted for in 19 accordance with applicable law, including, but not limited 20 to, the Financial Management Act of 1979. The allottee 21 shall be the Governor of the State of Yap who shall be

responsible for ensuring that these funds, or so much
