SECOND REGULAR SESSION, 1989 CONGRESSIONAL BILL NO. 6-131, C.D.1, C.D.2

Public Law No. 6 - 89

AN ACT

To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding public projects in Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$500,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1990, for the purpose of funding public projects in Kosrae
5 State.

6 Section 2. The sum appropriated under section 1 of this act
7 shall be apportioned as follows:


10 Section 3. All funds appropriated by this act shall be
11 allotted, managed, administered, and accounted for in accordance with
12 applicable law, including, but not limited to, the Financial
13 Management Act of 1979. The allottee of the funds appropriated
14 under subsections (1) and (5) of section 2 of this act, and
15 paragraphs (3)(c), (3)(d), (3)(e), (3)(f), (3)(g), (3)(h), (4)(b),
16 (4)(d), (4)(e), and (4)(f) of section 2 of this act shall be the
17 Chairman of the KSCIP. The allottee of the funds appropriated under
18 subsection (2) of section 2 of this act shall be the Mayor of Lelu
19 Municipality. The allottee of the funds appropriated under
20 paragraphs (3)(a) and (3)(b) of section 2 of this act shall be the
21 Mayor of Tafunsak Municipality. The allottee of the funds
22 appropriated under paragraphs (4)(a) and (4)(c) of section 2 of this
23 act shall be the Mayor of Malem Municipality. The allottee of the
24 funds appropriated under subsection (6) of section 2 of this act
25 shall be the Chairman of the Kosrae Congressional Delegation. The



1 allottees shall be responsible for ensuring that these funds, or so
2 much thereof as may be necessary, are used solely for the purposes
3 specified in this act, and that no obligations are incurred in excess
4 of the sum appropriated. The authority of the allottees to obligate
5 funds appropriated by this act shall not lapse until expended.

6 Section 4. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its becoming
8 law without such approval.
